## BRIEF BIOGRAPHIES FOR PANELISTS AND SPEAKERS ICKS-KAUPA JOINT ANNUAL CONFERENCE 2007

**Bae, Chang-Hee Christine:** Chang-Hee Christine Bae held the positions of Lecturer in the School of Urban and Regional Planning at USC and Vice-President of King R. Woods & Associates, Inc. of Los Angeles prior to joining our faculty in Autumn 1996. She holds a Ph.D. in Urban and Regional Planning from USC, a Master's in Regional Planning from SUNY, Albany, and a BA in Business Administration from Ewha Woman's University of Seoul, Korea. Dr. Bae's dissertation, "The Income Distribution Impacts of Air Quality Regulations: A Los Angeles Case Study," is one example of her work at the intersection of planning for diverse communities, sustainable urbanization, and environmental justice. The key finding is that poor people and poor communities gain most from cleaning up the air. The dissertation also challenges a widely held myth, namely that there is an unavoidable trade-off between jobs and the environment. The results of her dissertation and related research have appeared or are forthcoming in the *Journal of the American Planning Association*, *Environment and Planning*, and the *Journal of Environmental Management*. Within the professional world, Dr. Bae has ten years of experience as a planning consultant. She has recently worked on the environmental impact review for a new Learning Resource Center and Library on a historically and culturally sensitive site for a college focusing on underprivileged, largely minority students. She has also recently been project manager during the mixed use redevelopment project (with an affordable housing component) in a predominantly African-American neighborhood in South Central LA. She has been involved in several Rebuild LA projects, giving her an appreciation for social and community issues. Dr. Bae teaches in several different areas including sustainable urbanization, community planning for diverse neighborhoods, land use planning, transportation planning, and analytical techniques in planning.

**Baker, Richard W.:** Richard Baker was appointed Special Assistant to East-West Center President Charles Morrison in March 2003. He joined the East-West Center's research staff in 1988, following a 20-year career in the U.S. Foreign Service, and has served in a variety of positions including as interim director of the Center's research program in 2000. He holds a Master of Public Affairs degree in International Relations from the Woodrow Wilson School at Princeton University. His Foreign Service assignments included Singapore, Indonesia, and Australia, and various positions at the Department of State in Washington. Mr. Baker's areas of interest include U.S. foreign policy making, Asia Pacific regionalism, Southeast Asia (with a special focus on Indonesia), Australia/New Zealand, and the Pacific Islands. Among other current duties, he coordinates the Center's Islamic Initiative. He was the principal editor of *Indonesia: The Challenge of Change* (1999) and a co-editor and co-author of the 1997-2005 *Asia Pacific Security Outlook* series (he now leads the successor *Asia Pacific Security Survey*).

**Bradford, Schott C.:** Scott Bradford is Associate Professor of Economics at Brigham Young University and Non-resident Fellow with the Institute for International Economics (IIE). His research focuses on trade barriers in rich nations. He has written papers on the political economy of protection, with a particular focus on how job loss concerns influence trade policies. He has also produced estimates of the amount of protection in rich countries and has conducted Applied General Equilibrium analyses of the welfare effects of trade barriers. In addition, he has conducted studies of the Japanese economy, the Korean economy, and domestic distribution systems in rich nations. His work has appeared in *The American Economic Review*, *The Review of Economics and Statistics*, the *Journal of International Economics*, and *World Economy*. Bradford's IIE publications include *Has Globalization Gone Far Enough?* (2004), a book co-authored with Robert Lawrence; "The Payoff to America from Global Integration" (2005), a book chapter co-authored with Paul L.E. Grieco and Gary C. Hufbauer; and "Negotiating the Korea-United States Free Trade Agreement" (2006), a policy brief co-authored with Jeffrey Schott and Thomas Moll. Bradford joined BYU as a Visiting Instructor in 1997 and became Assistant Professor in 1998 and Associate Professor in 2005. He worked at IIE as a Visiting Fellow during the 2005-2006 academic year. He lived in Japan for a year and a half as a missionary for the LDS Church and for three months as an intern for the Japan International Cooperation Agency. He has a physics BA from Brigham Young University, an MPA from Princeton University, and a PhD in Political Economy from Harvard.

**Burghardt, Raymond:** Raymond Burghardt recently retired U.S. Ambassador to Vietnam, joined the East-West Center in January 2005 as the Director of East-West Seminars. He is the highest-ranking diplomat to join the Center since the 1960s. In February 2006, the Board of Trustees of the American Institute in Taiwan (AIT)

named Ambassador Burghardt Chairman of the AIT board. Burghardt holds the AIT position concurrently with his position at the East-West Center. AIT is a private corporation established in 1979 to manage U.S. relations with Taiwan in the absence of formal diplomatic ties. Ambassador Burghardt served as the Ambassador to Vietnam from 2001- September 2004. He was formerly the Director of the American Institute in Taiwan (AIT) from 1999-2001. He previously served as American Consul General in Shanghai (1997-1999), as Deputy Chief of Mission at the U.S. Embassies in Manila (1993-96) and Seoul (1990-93), and as Political Counselor in Beijing (1987-89). During the first six months of the Clinton Administration in 1993, Ambassador Burghardt served as Charge d' Affaires at the U. S. Embassy in Seoul. Ambassador Burghardt's previous positions also have included an assignment on the National Security Council staff as Special Assistant to President Reagan and Senior Director of Latin American Affairs. He also served at the U.S. Embassies in Honduras and Guatemala. He was a Peace Corps Volunteer in Colombia before joining the Foreign Service. Ambassador Burghardt received a B.A. from Columbia College in 1967 and did graduate study at Columbia's School of International and Public Affairs. He speaks Vietnamese, Mandarin Chinese and Spanish.

**Davis, Elizabeth Van Wie:** Elizabeth Van Vie Davis is a Professor at the Asia Pacific Center for Security Studies, where she focuses on Chinese domestic, foreign, and defense policies. Her work includes looking at China's role in the international community and in the Asia Pacific region. This involves looking at US-China relations, Chinese foreign policy, the security environment in Northeast Asia, and the development of China's domestic agenda. The rapid modernization of China has increased its global influence at an impressive pace. However, this reemerging China faces the dilemma of how to cope with domestic challenges, the international system, the Asia-Pacific region and the United States. Coming to the Asia-Pacific Center from Johns Hopkins University's, SAIS, Center in Nanjing, China, Dr. Davis was the Fei Yi-Ming Professor of Politics from 1998 to 2000. There she was responsible for conducting research and taught graduate classes on U.S.-China relations as well as international law and politics. Previously Dr. Davis held appointments at other universities. Dr. Davis holds a Ph.D. and M.A. in Foreign Affairs from the University of Virginia. While engaged in graduate studies, she conducted research at Beijing University, China, and completed Chinese language courses at Harvard University. Educated in the University of Chicago's Great Books program at Shimer College and Oxford University, she received her B.A. from Shimer College and completed economics courses at Harvard University and diplomacy courses at the Fletcher School of Law & Diplomacy. Dr. Davis's recent book publications include *Islam, Oil and Geopolitics* (2006), *Chinese Perspectives on Sino-American Relations* (2000) and *China and the Law of the Sea Convention* (1995). Her articles have appeared in numerous journals around the world, including *Asian Affairs*, *The Journal of East Asian Politics*, *World Environment Quarterly*, *Encyclopedia of Modern Asia*, and *Journal of Contemporary Asia*.

**Fargo, Thomas Boulton:** Admiral Thomas B. Fargo, USN (Ret.), former Commander of the U.S. Pacific Command, serves as President of Trex Enterprises Corporation, a privately-held high-technology company. Admiral Fargo also serves as Chairman and Chief Executive Officer of Loea Corporation, a high-bandwidth wireless communications company, and as Chairman of Sago Systems, Inc, a defense and homeland security company developing state-of-the-art technologies; both are subsidiaries of Trex Enterprises. Admiral Fargo joined Trex Enterprises on March 28, 2005, after a distinguished career serving the U.S. Navy and the Department of Defense. He was the twentieth officer to hold the position of Commander of the U.S. Pacific Command. As the senior U.S. military commander in East Asia, the Pacific and Indian Ocean areas, he led the largest unified command while directing the joint operations of the Army, Navy, Marine Corps and Air Force across 100 million miles. He was responsible to the President and the Secretary of Defense, and was the U.S. military representative for collective defense arrangements in the Pacific. Admiral Fargo also served as the 29<sup>th</sup> Commander-in-Chief of the U.S. Pacific Fleet from October 1999 to May 2002. His service as a leader in the Pacific was preceded by his command of the U.S. Fifth Fleet and Naval Forces of the Central Command during two years of Iraqi contingency operations from July 1996 to July 1998. His 35 years of service included six assignments in Washington, DC, in addition to five commands in the Pacific, Indian Ocean, and Middle East. Born in San Diego, CA, he attended high school in Coronado, CA, and Sasebo, Japan. Admiral Fargo graduated from the United States Naval Academy in June 1970. He is a 1989 recipient of the Vice Admiral James Bond Stockdale Award for Inspirational Leadership. Admiral Fargo is based out of Trex's Honolulu, Hawaii, office. In addition to his work at Trex, he serves on the Boards of Directors for Hawaiian Electric Industries, Hawaiian Airlines, and USAA. He is active in the community, serving on the Board of Directors of

the Japan-America Society of Hawaii, the Iolani School Board of Governors, and the Hawaii Pacific University Board of Trustees. He is the National Vice Chairman of the Pearl Harbor Memorial Fund.

**Fouse, David:** Dr. David Fouse joined the Asia Pacific Center for Security Studies as a Research Fellow in December 2002. His research interests are in Northeast Asian security issues with a special focus on Japan. His doctoral dissertation focused upon the development of postwar Japanese security issues, Japanese domestic politics and United States-Japan bilateral relations. Prior to joining the center Dr. Fouse taught various courses at the University of Hawaii. Dr. Fouse received both his Ph.D. and M.A. in political science from the University of Hawaii, and a B.A. in political science at the California Polytechnic University at Pomona. At the University of Hawaii Dr. Fouse was a Research Assistant for the School of Hawaiian, Asian, and Pacific Studies and participated in the Japan-United States Hawaii Conference on the Future of Security in Northeast Asia in 1991. While working to complete his Ph.D. at the University of Hawaii Dr. Fouse received a research grant for fieldwork from the Japanese Ministry of Education in 1996. Dr. Fouse ended up staying in Japan for 5 years and completed a Ph.D. in applied statistical science at the Graduate University for Advanced Studies in Tokyo, Japan. During this time Dr. Fouse participated in several nation-wide surveys of Japanese values carried out by the Institute of Statistical Mathematics in Tokyo and translated reports of these surveys into English. Dr. Fouse has recently published an article on the effects of economic stagnation in Japan on support for democratic values in the journal *Behaviormetrika*. His recent APCSS publications have dealt with Japan's ongoing debate over development of a missile defense system, Japan's China Debate, and Japanese policy toward North Korea in the post Cold War era. Dr. Fouse is a member of the Japan Political Studies Group of the American Political Science Association and the Behaviormetric Society of Japan.

**Hyun, Kwang On:** Retired Major General, Hyun, Kwang-On is currently the Vice Chairman of the Council on Korea-U.S. Security Studies. He was the Director of Planning and Coordination Department, the Korean Veterans Association from 2000-2003. He worked in LG Precision Co., Ltd, as a Senior Vice President from 1996-2000, after successful military career of the ROK Army. The last period of his military career, general Hyun served as the Deputy ACofS, C-3, ROK-US Combined Forces Command from 1991-1994. He also served as the Executive Officer to the Minister of National Defense from 1989-1990, from 1988-1989 he served as the Chief of Staff, ROK Defense Security Agency, and from 1986-1987 he served as the Chief of the Intelligence Department, ROK Defense Intelligence Agency. From 1983-1984 general Hyun commanded the 5<sup>th</sup> Field Artillery Group in 5<sup>th</sup>ROK Corps. His awards include the Order of Military Merit Inheon Medal, the Order of National Security Merit Chunsu Medal, and the US Legion of Merit. General Hyun received M.A. in Public Administration from Hanyang University in 1991 and in 1965 he graduated from the Korean Military Academy.

**Jeong, Dong-Keun:** Dr. Jeong is currently a professor in the Department of Economics and has served as faculty director of the Learning Resource Center at North Carolina A&T State University (A&T). Dr. Jeong was educated at Kyung-Puk National University (Taegu, Korea), University of Hawaii, Columbia University, and Wayne State University. He was a recipient of the prestigious East-West Center Scholarship for the years 1964-66. Professor Morgan has concentrated his research primarily on national and international security matters - deterrence theory, strategic surprise attack, arms control, and related subjects. He has also had a long standing interest in theoretical approaches to the study of international politics. Currently he is involved in projects on the theory and practice of deterrence in the post-Cold War era, security strategies for global security management, and security in Northeast Asia. His latest major publications are *Deterrence Now* (Cambridge University Press, 2003) and *International Security: Problems and Solutions* (CQ Press, 2006).

**Morrison, Charles E.:** Charles E. Morrison has been president of the Center since August 1, 1998. He has had extensive involvement in the conceptualization, organization and funding of policy-oriented educational research and dialogue projects in both Japan and the United States, and has long been involved in promoting the concept of Asia Pacific community. In September 2005, he was elected international chair of the Pacific Economic Cooperation Council (PECC). He is a founding member of the U.S. Asia Pacific Council, the U.S. National Committee for Pacific Economic Cooperation and a member of the U.S. Committee for Security

Cooperation in Asia Pacific. He is a past chair of the U.S. National Consortium of APEC Study Centers. A former director of the Center's Program on International Economics and Politics, he is a former U.S. Senate aide and a research adviser to binational Japan-U.S. commissions. He holds a Ph.D. in international relations from Johns Hopkins School of Advanced International Studies. Publications in recent years include: *Japan, ASEAN, and East Asia from an American Perspective*. *Community Building with Pacific Asia (report to the Trilateral Commission)*. *ASEAN: Forum, Caucus & Community*. *Asia Pacific Crossroads: Regime Creation and the Future of APEC*. *Development Cooperation in the 21st Century: Implications for APEC*. *Asia Pacific Security Outlook: 2005 (annually from 1997)*.

**Noerper, Stephen E.:** Dr. Steve Noerper is a senior professor at New York University's Center for Global Affairs. He teaches on modern Korean security and international relations and appears widely in media and at international conference events. He has served on Korean issues with the US State Department, a Georgetown-based international relations firm, and as director of Washington programs for the Nautilus Institute. He has taught graduate and professional classes on Korea at American University, Waseda University, the National University of Mongolia and the Asia-Pacific Center for Security Studies. Dr. Noerper has served as a Fulbright Senior Scholar and foundation director in Asia. He is a graduate of the Fletcher School of Law and Diplomacy and London School of Economics.

**Paik, Soon:** Dr. Soon Paik is a Senior Economist of the U.S. Department of Labor - Bureau of Labor Statistics. He taught economics, econometrics, statistics, and management at the University of District of Columbia as an Associate Professor. He worked as a project developer of the Construction Labor Demand System in the Tennessee Valley Authority, Knoxville, Tennessee, and as an Associate Director of the Construction Resources Analysis and a Research Professor of the University of Tennessee. He serves as a Senior Economic Consultant of the United Nations Development Programme for the Taebaek Iron Development Project in the Republic of Korea. He graduated from the Law College of the Seoul National University (LLD), and obtained M.A. degrees in economics from the Korea University and from the Ohio University and a Ph.D. in economics from the West Virginia University. His major interests are in the international economics, South and North Korean economies, economic issues of the Korean unification, resources and labor economics, economic model-building, statistical analysis, etc. He published numerous professional articles in the various academic journals, and led many seminars and paper presentations in the professional societies including American Economic Association, American Statistical Association, etc., on the subjects concerning international economics, South and North Korean economies, energy economics, construction economics, international labor economics, etc. He has been working as an economic columnist of the Chosun Ilbo Washington and of the KNN radio. He served as a Vice President of the Korean American Economic Association and as a President of the Korean Economic Society in Washington, D.C. His civic activities included a President of the Knoxville Korean Association, a President of the Seoul National University Alumni Association in Washington, D.C. He has been serving as a Ruling Elder of the Korean Central Presbyterian Church, Vienna, VA.

**Park, Yoon-shik:** Dr. Yoon-shik Park is currently Professor of International Banking & Finance at The George Washington University in Washington, D.C. In addition to George Washington University, he also taught at Georgetown University and Columbia University. Among his many publications are five books: *Project Financing and International Financial Markets* (1999), *International Banking and Financial Centers* (1989), *International Banking in Theory and Practice* (1984), *Oil Money and the World Economy* (1976), and *the Eurobond Market: Function and Structure* (1974), in addition to many articles and reports in the fields of international banking and finance. Before joining the academia, he started to work for the World Bank in Washington in 1970, first as a Young Professional and later as a Senior Economist. Currently, Dr. Park is a member of the boards of directors of both Samsung Corporation in Korea and the Korea Economic Institute of America, Inc. Dr. Park has been a consultant to the World Bank, Asian Development Bank, International Finance Corporation (IFC), Inter-American Development Bank, U.S. Agency for International Development (AID), U.S. Federal Reserve, Overseas Private Investment Corporation (OPIC), U.S. Export-Import Bank, and numerous other private and public institutions around the world. Prof. Park has two doctorate degrees: Doctor of Business Administration (DBA) in International Finance from Harvard University Graduate School of Business Administration and Ph.D. in Economics from George Washington University, in addition to his MA in economics and MBA in finance.

**Pastreich, Emanuel Yi:** Emanuel Pastreich is an assistant professor of Japanese Studies at Parkland College in Champaign, Illinois. Emanuel has written extensively on the history, thought and literature of Korea, China and Japan. Most of his work has concerned the intellectual, cultural and political relations between Korea, China and Japan from the seventeenth century through the twentieth century. Emanuel's forthcoming book focuses on the reception of Chinese vernacular narrative in Korea and Japan. More recently, he has written on globalization and social change, the internet, Taiwan Straits issues, Chinese-American relations, and North Korea. Emanuel has made an effort to interpret recent developments in Asia in light of precedents from the early modern and pre-modern period. Emanuel graduated from Yale College in the major of Chinese Language and Literature in 1987. He spent his junior year abroad at National Taiwan University taking courses in Chinese literature and culture. Emanuel went on to receive an M.A. in Comparative Culture from University of Tokyo in 1992 for which he wrote a thesis in Japanese. He received a Ph.D. in East Asian Languages and Civilizations from Harvard University in 1997. In addition, Emanuel conducted research at Seoul National University (1995-96) and at Korea University (1997) in Korean and Chinese studies. He has taught at Harvard University, University of California Berkeley, and the University of Illinois Urbana-Champaign.

**Ra, Jong O.:** I received my Ph.D. in political science at the University of Illinois, Champaign-Urbana and have since engaged in teaching and research to date at the University of Illinois, Hollins University, and Virginia Tech. I have published in the area of American government, particularly presidential elections and voting behavior, Korean politics, among others. I am currently John P. Wheeler Professor and Chair of the Department of Political Science at Hollins University and hold a joint appointment in the Department of Political Science at Virginia Tech.

**Rhee, Hang Yul:** (LL.B., College of Law, Seoul National University; M.A., Graduate Faculties, Columbia University; Ph.D., American University; Post-doctoral Studies, Johns Hopkins University.) Dr. Rhee was awarded the title of Distinguished Professor of International relations at Shepherd University. Currently he is serving as chairman of the Governing Board of International Council of Korean Studies (ICKS) and served as president of the Korean American University Professors Association (KAUPA). He was also president of the Association of Korean Political Studies in North America from 1989-1991. Before embarking on his academic career, he worked as a legal research fellow at The International Bar Association and also at the law firm of Debevoise, Plimpton, Lyons, & Gates in New York City. He has been active in many civic organizations outside of the academic world. He was president of the Korean Student Federation in the United States while attending Columbia University in New York in 1963 and 1964. Since 1964, he has worked in many capacities for the Korean community in the United States. He also contributed many articles and wrote columns for *Cho Sun II Bo* and *Han Kook II Bo* of Washington Editions. Dr. Rhee served as an advisor for the Advisory Council for Peaceful Reunification of Korean in the greater Washington, D.C. area since 1984-2002. As a result of his many contributions to the Korean community, he received the Presidential Medal of Honor from the Republic of Korea in 1998. Dr. Rhee started his teaching career at Clark University in Worcester, Massachusetts in 1966 and 1967. He was an assistant professor at Muskingum College in Ohio in 1967 and 1968. While teaching at Shepherd, he also served as a representative and founding member of Faculty and Course Development in International Studies in the state of West Virginia from 1981 through 1996. This resulted in the Governor Award for his effort. He has also received the National Endowment for Humanities Scholarship in 1978. His numerous articles have included contributions to *Asian Forum*, *East Asia Journal*, *Korean and World Affairs*, and *Korean Observer*. Dr. Rhee specializes in Korean unification issues, development theory and political economics.

**Richardson, Harry W.:** Harry W. Richardson is the James Irvine Chair of Urban and Regional Planning in the School of Policy, Planning and Development at the University of Southern California. He has published 26 books (some of which are edited) and about 200 research papers. His current research efforts are primarily focused on the economics of terrorism within the CREATE (Center for Risk and Economic Analysis of Terrorism Events) research center at USC. Other research interests include spatial economic modeling, urban transportation, urban sprawl, congestion pricing, Korean reunification and globalization. He was an Overseas Visiting Fellow at Churchill College, Cambridge University in the United Kingdom in Fall 2004 and Spring 2006, and a POSCO Visiting Fellow at the East-West Center in Honolulu in November-December 2006. In 2004 he was awarded the Walter Isard Award for Scholarly Achievement in Regional Science by the Regional Science Association International.

**Roehrig, Terence Jr.:** Terence Roehrig is an Associate Professor in the National Security Decision Making Department, at the U.S. Naval War College. He received his PhD from the University of Wisconsin-Madison. He is the author of two books, *From Deterrence to Engagement: The U.S. Defense Commitment to South Korea* (2006) and *The Prosecution of Former Military Leaders in Newly Democratic Nations: The Cases of Argentina, Greece, and South Korea* (2002) and coeditor of a forthcoming book, *Korean Security in a Changing East Asia* (2007). He has published articles and book chapters on North Korea's nuclear weapons program, Korean security issues, the U.S.-South Korea alliance, human rights, and transitional justice. Dr. Roehrig is also the current Secretary/Treasurer for the Association of Korean Political Studies.

**Ryoo, Jae Kap:** Dr. Ryoo is currently a professor emeritus at the College of International Studies of Kyonggi University. He had taught theory of international relations, foreign policy, and security strategy, and retired in February 2007. He was the Dean of the Graduate School of Unification, National Security and Social Welfare in 2000-2002. He is also a board member of the Council on the Korea-U.S. Security Studies. Dr. Ryoo was the past President of the Korean Association of International Studies in 1999 and a professor at the Korea National Defense University (KNDU) from 1980 to 1994 and Korean Military Academy from 1970 to 1974. He was also the Director of Military Research Institute of National Security Affairs at KNDU and a Visiting Professor to the U.S. National Defense University in 1985-1986. He received a B.S. from the Korean Military Academy and B.A and M.A in International Relations from Seoul National University. He also holds M.A and Ph. D. degrees in Political Science from Indiana University. He is the author of some 100 books and articles on war, peace, strategy and diplomacy, South-North Korean relations and unification issues, and Korea-U.S. security relations.

**Shin, Eui Hang (Ken):** Dr. Shin is Professor in the Department of Sociology, University of South Carolina, Columbia, South Carolina. He is Visiting Professor, Faculty of Liberal Education, Seoul, National University, Seoul, Korea for the 2006-2007 academic year. His areas of interest are the political demography of Korea and Korean American communities. His recent publications include: "State, Society, and Economic Development in a Sport Life Cycle: The Case of Boxing in Korea," *East Asia: An International Quarterly* 24 (1), (Spring 2007), forthcoming.
